NARRATIVE

On 03/10/04 I was assigned to do further follow up investigation on the Kent HEITHOLT homicide case. I was assigned to speak with a possible witness in the case, Dallas MALLORY. I was advised MALLORY may have talked to the suspects in this case on the night of the homicide.

I made contact with MALLORY in an interview room in the Major Crimes unit. I asked how he was familiar with the suspects, Charles ERICKSON and Ryan FERGUSON. MALLORY began by saying that the was older than the two, but he went to school with them. He believed FERGUSON may have played soccer for Rock 3ridge High School. He said he had seen ERICKSON at various parties around lown, and he had contact with ERICKSON parties at his house, and at other places. I asked MALLORY about the events on Halloween night 2001. MALLORY originally told me he went out on Halloween night and had a costume on like a solice officer. I asked him if he had seen either ERICKSON or FERGUSON that right, and he stated he could not remember.

I advised MALLORY we had information he had in fact spoke with one of he suspects, ERICKSON or FERGUSON on the night of the homicide. MALLORY tated he did not believe he did so, and he would be willing to take a voice tress analysis examination to prove to investigators that he did not talk to ither. I administered a voice stress analysis asking questions as to whether e knew who had killed the Tribune reporter, Kent HEITHOLT, and if he suspected ny one of doing that crime. After reviewing the results of the voice stress nalysis examination, I advised MALLORY it appeared to be deceptive indicator.

We talked further, and Detective Harmon showed MALLORY a picture of ERIC peaking with ERICKSON on Halloween night 2001. MALLORY told me he had been dr n all day. He explained he worked at FORUM DRY CLEANERS, and he wore the unifo the Blue Note later that evening. He said he had been drinking that night, and that evening. He said he could not remember the location of that contact, but worked up. MALLORY said ERICKSON told him he had "beat someone down." He s ing in his hand, but he could not recall what. I inquired as to whether he ha he stated he could not recall.

I asked MALLORY if he had any further information about the events of Ha ig further.
