NARRATIVE

on 03/10/04 at about 1000 hours, myself and Detective Tim Giger went to the ' rum Dry Cleaners located at 1400 Forum Boulevard in an attempt to locate las Mallory to interview him in reference this case. This was in reference o LEAD 213. Upon arrival, contact was made with Mallory. We requested that Ir. Mallory accompany us to the Columbia Police Department for an interview. Ir. Mallory agreed to do so. Mr. Mallory did inquire as to what this concerned. 'e advised Mallory that we would discuss this once we arrived at the Police epartment. Mallory asked if he "needed an attorney". I advised Mr. Mallory hat I could not provide him advice in this area, and this would be up to him o decide. Mallory then agreed to go with us to the Police Department.

pon arrival at the Police Department, we escorted Mr. Mallory to an interview oom. I advised Mr. Mallory that he was not under arrest, but further advised im that I would be reading him his rights in case it was later determined that e was in custody. I then advised Mr. Mallory of his rights persuant to the iranda decision. Mallory stated he understood his rights and then indicated is willingness to waive his rights and began to speak with us about this nvestigation.

first asked Mallory if he knew Chuck Erickson. Mallory stated he did not now anyone by this name. I advised Mallory what I was investigating, and irther advised him that Erickson had specifically named him as a person that saw shortly after the homicide. Mallory again denied knowing Chuck Erickson. asked Mallory if it would help to show him a picture of Charles Erickson. illory stated this might help. Detective Giger then showed Mallory a mugshot

photograph of Erickson. Mallory then stated that he did indeed recognize this individual. Mallory then claimed to know Erickson "by face" but contended that he did not know his name. Mallory stated that Erickson was "crazy" and that he did not associate with him because of this. Mallory stated he hadn't seen Erickson for two or more years and that Erickson ran with a guy named Hayes Broyle. I advised Mallory that Erickson claimed he had spoken with him shortly after the homicide somewhere near the Tribune building. Mallory stated he remembered the Halloween of 2001 and stated that he had gone to the Blue Note to participate in a Halloween costume contest. Mallory stated he usually does this on Halloween, and that he usually goes to the Blue Note because of their connection to BXR radio. Mallory denied going to By Georges and stated that he does not go to By Georges because he "doesn't care for By Georges". Mallory went on to state that he remembers this Halloween well, and that he was dressed as a Police Officer for Halloween. Mallory continually denied seeing Erickson C.F 812

I then made contact with Charles Erickson in an interview room in the Major Crimes unit in reference this discrepancy. I asked Mr. Erickson about his contact with Mallory, and in particular I asked Erickson how Mallory was dressed. Erickson stated that Mallory was dressed like a Police Officer.

[then re-contacted Mallory with this new information, and Mallory still denied this contact. I asked Mallory if he knew Ryan Ferguson. Mallory denied thousing Ryan Ferguson. Mallory stated if he saw a picture of Ferguson, he fight recognize him. I did not have a photograph of Ferguson at this time.

Ouring our conversation with Mallory, it did appear that he was being completely truthful. Mallory maintained that he was telling the truth. I then sked Mallory if he would be willing to submit to a truth verification xamination to verify his statements. Mallory stated he would be willing to do his.

then contacted Detective Jeff Westbrook, a certified Computer Voice Stress nalysis operator with the Columbia Police Department. I briefed Detective estbrook on the content of my interview with Mr. Mallory and the issues of ontention from this interview. I then introduced Mr. Mallory to Detective estbrook. Detective Westbrook then escorted Mallory to the major Crimes Unit here the CVSA examination and further interviewing took place. For additional, se supplement by Detective Jeff Westbrook.
