Tye stated that employees leave the bar around 2:00 to 2:15 A.M. Mr. Tye stated the latest he can remember employees taking to close the bar is 2:30 A.M.

I asked Mr. Tye about the cleaning crew that cleans the bar. Mr. Tye stated the cleaning company the bar used was Smith Janitorial Services. Mr. Tye stated Smith Janitorial Services had a key to get in the bar. Mr. Tye stated Smith Janitorial Services cleans at 5:00 or 6:00 A.M.

I asked Mr. Tye if any of his employees or bouncers knew either Ryan Ferguson or Charles Erickson. Mr. Tye stated to his knowledge none of his employees or bouncers knew Ferguson or Erickson. Mr. Tye stated he didn't believe that Ferguson or Erickson were frequent customers.

Mr. Tye stated that if I had anymore questions he would be willing to help out in anyway.
